Getting an Idea...

The Business Plan

The first step in starting a business is putting together a plan. There are many factors that go into putting together a business plan. These factors include an **Outline of Goals, Marketing Strategy, Financial Management, and Operation Schedule.**

☐ Outline of Skills/Goals

- What are the goals of the business?
- Who owns the business?
- What advantages do you have?

☐ Marketing Strategy

- What market do you serve?
- How will you market/advertise your product?
- How will you price your product?

☐ Financial Management

- Where will you find funding?
- What is your business's operating budget?
- What are your immediate/extended costs?

☐ Operation Schedule

- Who will manage day-to-day operations, and how?
- What type of employees will you need?
- What equipment/facilities will be needed?

SCORE, Small Business Development Center and North Georgia Technical College provides free counseling in writing up a business plan. Your local Chamber of Commerce also has a comprehensive *How To Start A Small Business* guide.

Legal Structures

Before beginning a business, you must consider a legal structure that protects you and your assets from liability.

<u>Sole Proprietorship</u> - An individual owns the business, but is also liable for debts of that business.

<u>Partnerships</u> - Two or more people share in business's profits/expenses/operations. A *limited partnership* allows individuals to share in the profit/loss of a business, but not the operations of the business.

<u>Corporation</u> - Licensed by the state, this model allows the selling of common or preferred stock. This model will also be taxed twice: once on the business and second on stock dividends.

<u>Limited Liability</u> - A mixture of partnership and corporation, this structure allows partners to own and operate their business while shielding themselves from liability.

Note: Please consult with a legal professional before building a legal structure. SCORE can also furnish a workbook which outlines legal terminologies.

Getting Financed...

Although it is a common belief that free grants are available to support small business start-up and growth, this is not true! There is no such thing as free money. However, there are many low interest loans and financial support programs which can help you start and grow your business. A few of these resources are listed below.

<u>Small Business Administration Loans</u> - This federal loan program helps small businesses acquire guaranteed capital at a fixed rate. Visit <u>www.sba.gov</u> for additional information.

<u>USDA Loans</u> - This federal program offers financial assistance to small businesses. It is specifically designed to grow business in rural areas. Please visit <u>www.rurdev.usda.gov</u> or call 1-800-670-6553 for more information.

<u>Microloans</u> - This special type of loan is given by nonprofit organizations to support low-income, lowemployee entrepreneurs. For more information on microloans, contact ACE at www.aceloans.org.

Getting Licensed...

<u>Getting licensed with the state</u> - Certain businesses require licensing with the state. Contact the Secretary of State's office (<u>www.sos.georgia.gov</u>) to see if your business requires special licensing. <u>NOTE:</u> Business licenses are required within the city limits of both Hiawassee and Blairsville.

<u>Licensing and Sales Tax ID</u> - Your business may be required to obtain a seller's permit, and all businesses must receive a Tax ID. Contact the Georgia Department of Revenue (www.etax.dor.ga.gov) and the Federal Internal Revenue Service (www.irs.gov) to obtain these permits.
